# Location

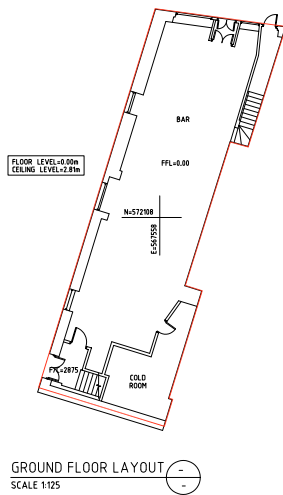
- ♦ Tompkins commands an excellent trading position in the centre of the city overlooking the River Lee adjoining Merchants Quay Shopping Centre and the Cork Opera House and is strategically located between the St. Patrick's and Christy Ring bridges.
- ♦ The location of Tompkins is one of the focal points of Cork City especially as it adjoins the Opera House and other adjoining properties are a mix of business, banking and retailing concerns serving Cork's business and residential populace throughout the day and is also in one of the night-time entertainment districts of the city.
- ♦ Cork City as of the 2016 Census, had a population of 125,000, but following a boundary extension in 2019, the population increased to 210,000.
- ♦ Cork is the Republic of Ireland's second largest city and is the premier commercial, retail, administrative and educational centre in the south. Cork has an excellent infrastructure and is easily accessed through a principal port and an international airport.
- ♦ Cork railway and bus stations adjacent to Tompkins offer daily services to all major cities throughout the country and hourly trains to Dublin.
- ♦ Major employers in Cork include Apple (next to the Opera House), Amazon, Dell EMZ, Pfizer, Boston Scientific and PepsiCo.

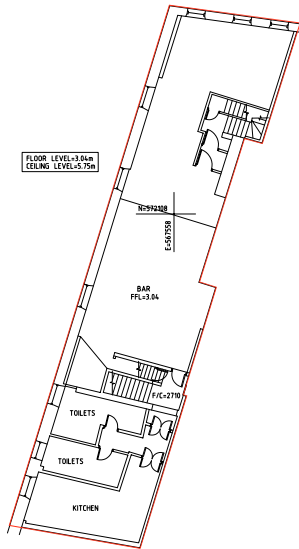

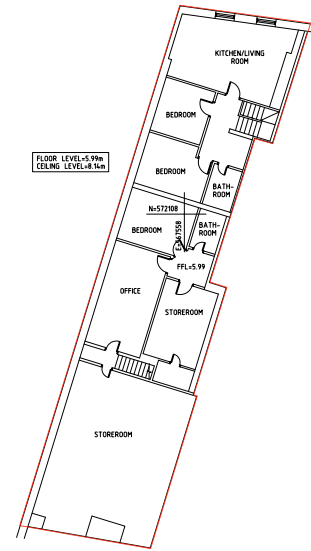
